Happy New Year everyone! I hope that the festive season was filled with happiness and fellowship. Together we have entered a new decade as 2019 left and 2020 began. As of January 1 2020, new taxation laws have come into effect.

The province keeps downloading more costs onto municipalities and cutting funding through MSI grants as such, we will need your support to keep pressuring our MLA and MP for infrastructure and other municipal grants.

The town has passed an interim budget. This budget contains a 2.42% tax increase. Water will increase by 10 ¢ a cube due to an increase by ACE (water authority). There is also an increase in assessment from the Eagle Hill Foundation.

We will continue to move forward with our infrastructure upgrades. 2020 will also see the arena upgrade starting in March.

We are in for a busy 2020. Till the next newsletter, I hope 2020 is a happy and prosperous year for everyone.

Snow Removal

-Please keep your neighborhood accessible this winter by removing snow and ice from sidewalks and ramps near your home or business

-Do not shovel snow on to the street, this can create a hazard and reduces effectiveness of snow clean up by Public Works

Remember as per Traffic Bylaw 2019-988: All persons owning, occupying or controlling premises in all areas of the Town shall remove and clear away all snow, ice, dirt, and other obstructions from the sidewalk in any highway adjoining such premises within 48 hours of the time that such snow, ice, dirt, or other obstruction was deposited thereon.
