

Town Council is providing an opportunity for the general public to individually address Council on any topic relevant to municipal government for a period not to exceed 2 minutes per person to a maximum of 20 minutes combined. Information presented to Council may or not be acted on and will not be debated unless there is a majority vote to do so. The Open Forum is not a means of expressing insults, accusations or making any personal attacks on any member of Council or Staff. Any person who starts insulting or making accusations or attacks on any member of Council, Council as a Whole, or any Staff member will be kindly asked to remove themselves from Council Chambers. Once again, welcome.

Division 3 - Open Forums

- 11.1 Individual members of the public who constitute the audience are be provided an opportunity as part of the meeting to address the Council on any topic relevant to municipal government for a period of time not to exceed two (2) minutes per person. The intent of which is to provide the person opportunity to address Council.
- 11.2 The information or comments heard may or may not be actioned by the Council. After a person has spoken, any Councillor may, through the Mayor or other presiding officer, ask that person or the Chief Administrative Officer relevant questions but may not debate the matter or the answers.
- 11.3 Actions by Council may only be 1) receiving the information without debate; 2) referred without debate to a Standing Committee or the Chief Administrative Officer for a report; or 3) debated if by a 2/3 majority vote a resolution is passed to allow a motion to be made without notice.

- 1. **Risk Management Session with 13 Ways**. Council & I had our 3rd one day workshop with Doug Griffiths & Golnaz Azimi on Monday October 5th, continuing to deal with risk management in our municipality for infrastructure replacement. The sessions are so beneficial and have provided us with more tools and more to think about. It will really help us planning for the future of the Town.
- 2. Two Hills Swimming Pool. Insurance has informed us that they will not be covering any of the cost to fix the damage to the roof caused by water leaks. The swimming pool authority has met and have made the tough decision that they will not be able to fix the pool roof and the building needs to be closed down. Insurance does not want to pay to remove the roof. I am working on trying to get insurance to pay to remove the roof (estimated at \$35-40K). The roof has to be removed to be able to take down the scaffolding. This would be an extra cost for us.
- 3. **Municipal Stimulus Program (MSP)**. No word yet from Municipal Affairs about our application to use the <u>\$171,000 for crushing of concrete</u>. We have decided to wait until spring to crush the concrete so that we have the money for the project.
- 4. Municipal Operating Support Transfer (MOST). This new program is how municipalities will receive the operating funding announced on July 17, 2020, as part of the Safe Restart Agreement between Alberta and the Government of Canada. MOST is designed to be a simple and straightforward program with few restrictions or administrative requirements. Municipalities will receive their funding shortly after execution of the funding agreement (sent September 30th), and no application is required. The funds may be used to support additional costs or revenue shortfalls associated with the COVID-19 pandemic and actions taken in response to it. The Town of Two Hills is to receive \$151,117.


