**NEW BUSINESS:**

**2020-998 Property Tax Bylaw**

The 2020 Budget has been passed with total revenues and expenditures of \$ . Of this amount, \$ comes from grants, penalties and transfers with the balance of \$ being raised through municipal taxes, fees, special taxes, requisitions and levies. Figures will be presented at the next council meeting on June 23, 2020.

**2020-999 Recreation Tax Bylaw**

The Municipal Government Act permits a municipality, by bylaw, to impose a special tax for this purpose under Section 382(1)(l) to benefitting properties (695 properties).

**2020-1000 Medical Incentive Tax Bylaw**

The Municipal Government Act permits a municipality, by bylaw, to impose a special tax for this purpose under Section 382(1)(h) to benefitting properties (703 properties).

**2020-1001 Maintenance Tax Bylaw**

The Municipal Government Act permits a municipality, by bylaw, to impose a special tax for this purpose under Section 382(1)(f) to benefitting properties. The benefitting properties are any properties that are adjacent to a road, or water and/or sewer main lines (692 properties).

**FCM MAMP Proposal**

Federation of Canadian Municipalities Municipal Asset Management Program Grant (FCM MAMP) (80% covered up to \$50,000).
