### **OPEN FORUM**



(Council Procedural Bylaw, Amendment Bylaw 2014-949)

**Preamble:** Welcome. Town Council is providing an opportunity for the general public to individually address Council on any topic relevant to municipal government for a period not to exceed 2 minutes per person to a maximum of 20 minutes combined. Information presented to Council may or not be acted on and will not be debated unless there is a majority vote to do so. The Open Forum is not a means of expressing insults, accusations or making any personal attacks on any member of Council or Staff. Any person who starts insulting or making accusations or attacks on any member of Council, Council as a Whole, or any Staff member will be kindly asked to remove themselves from Council Chambers. Once again, welcome.

### Division 3 – Open Forums

- 11.1 Individual members of the public who constitute the audience are be provided an opportunity as part of the meeting to address the Council on any topic relevant to municipal government for a period of time not to exceed two (2) minutes per person. The intent of which is to provide the person opportunity to address Council.
- 11.2 The information or comments heard may or may not be actioned by the Council. After a person has spoken, any Councillor may, through the Mayor or other presiding officer, ask that person or the Chief Administrative Officer relevant questions but may not debate the matter or the answers.
- 11.3 Actions by Council may only be 1) receiving the information without debate; 2) referred without debate to a Standing Committee or the Chief Administrative Officer for a report; or 3) debated if by a 2/3 majority vote a resolution is passed to allow a motion to be made without notice.

- 1. Non-Medical Masks Packing Work Bee. A BIG THANK YOU to Town Council and the other 12 people that volunteered to pack 12,000 non-medical masks supplied by the province. In under 3 hours, they had all the masks packaged into plastic bags of 4 masks. What a great group and good JOB! Masks are available to the public, just drop by the Town Office and we will be happy to provide them for you.
- 2. **Risk Management Session with 13 Ways**. Council & I met with Doug Griffiths & Golnaz Azimi for a one day workshop on Tuesday August 11<sup>th</sup>, dealing with risk management in our municipality for infrastructure replacement. This was a very good session and we are looking forward to the next session in September.
- 3. **Meeting with Minister Panda and MLA Jackie Armstrong-Homeniuk**. Council & I had a short but informative meeting on August 13<sup>th</sup> with Minister Panda & MLA Jackie Armstrong-Homeniuk. We had a good discussion about the state of infrastructure in the Town of Two Hills, the cost of replacement, and the lack of grants available. We stressed that we are not able to generate enough revenue through taxes or other revenue streams, to be able to replace infrastructure that is near end of life or past. We are not unique in the large amount of infrastructure debt to replace old water & sewer lines and then pave broken up road surfaces and replace crumbling sidewalks.
- 4. **Sidewalk Replacement and Curb & Gutter**. The Town of Two Hills has numerous sidewalks being replaced and some with curb & gutter. The plan is to have sidewalk on only one side of the street and curb & gutter on the other. The sidewalk will be replaced with grass, so some residents will not have to shovel snow in the winter.
- 5. **SB-90 Road Work**. The Town of Two Hills Public Works have been busy working on three sections of road. The old surface has been rotovated and the material hauled away, then mixed with more oil and gravel and hauled back and packed down. A good job has been done on these roads.

BACKGROUND:

Lift Station Issue - Pumps went down after lunch on Friday July 31st, 2020 (long weekend). The relay on the control panel failed for the pumps at the lift station, which caused both pumps to stop working and neither got a signal to turn on. We need the pumps on separate relays, so if one goes down the other will still turn on. The alarms did not go off to warn Public Works that the pumps were not working. Sewer kept flowing and was not being pumped through the lift station to the lagoon, so it started to build up in the pipes and backed up at Cougar Tire and to some of the houses to the south. Public Works got the pumps at the lift station working again shortly after 4:00 pm. This is only a temporary fix. The control panel needs to be replaced and this includes the alarms.

### **DISCUSSION:**

Cost for the control panel and installation is estimated at \$21,000. Recommended to set aside another \$1500, depending if other items need replaced. They will also check out if any other instrumentation, such as level, pressure or flow meters need replaced. The replacement was not budgeted for, but it is essential to the operation of the sewer system and needs to be replaced as soon as possible.

Dear Honourable Prasad Panda, MLA. Minister of Infrastructure

On behalf of my council and the residents of the Town of Two Hills, I am glad that you and Jackie found the time to meet us on Thursday, August 13<sup>th</sup>. I would like to apologize for my forcefulness, but the passion for my community gets the best of me sometimes. Your time with us was very short and that was not anyone's fault. During my time, I have worked with members from both provincial and federal governments. Time passes very quickly, making it difficult to stick to a schedule.

We stated a few of our issues, but as was said these are not unique to rural Alberta communities. As a viable town, we do the best we can with our limited resources. Reserves have never been a part of the town's budget or finances. There are numerous reasons for this, but we need not dwell in the past.

I do have a problem with our large urban centers, who because of size and bully mentality seem to get the largest piece of the pie. It seems we forget that a large portion of Alberta's wealth comes from rural Alberta. People who live and work in rural Alberta have the same needs as our large urban centers. Our smaller urban size creates many challenges to be able to provide these services.

I have a few ideas which may help the provincial government and the Town move forward in the future.

- 1. The federal gas tax, for example, is five cents per litre. We sell about 20 to 30 million litres in the community, which works out to over one million dollars. As a community we only receive around \$80,000, the rest goes to the larger urban centers. I don't know what the county gets, but if we added everything together, it probably doesn't come close to the amount of money that goes out. A larger piece of the pie would help us immensely, because the money comes out of our community.
- 2. Amalgamation of municipalities, where counties and urban areas become one community by eliminating artificial boundaries which are archaic and no longer work. There would be cost savings and more resources to work with as one municipality.
- 3. Make everyone equal and what I mean is:
  - a) Currently if municipalities have matching funds for grants, priority is often given to them. Smaller communities do not have the luxury of large commercial tax bases, linear taxes, and reserves which can be used. Communities with reserves should not receive funding on the same per capita basis until they use up their reserves. There are hundreds of millions of dollars sitting in reserves while the rest of the smaller municipalities continue to struggle.
  - b) Giving all rural citizens access to similar broadband services, either through Telus or some other provider. This would allow tech companies to locate anywhere and set down roots. It would also help existing manufacturers to service their customers more easily.

I would like to conclude by saying that my passion for my community and rural Alberta runs deep. Solutions are out there and can be achieved when we work together.
