At the end of December, the town received notice that the cost of water was increasing. Some of the increase was due to the purchasing of water, utility costs, etc. There are also requisition increases coming in 2024.

The end of December also saw some service disruptions at our health care facility. Though these are Alberta Health Services (AHS) problems, the town, county and our MLA are part of the discussions. Finding a solution is challenging but AHS is hoping to have something in the new year.

On a brighter note, the Town and Village of Myrnam both received Alberta Community Partnership grants for Intermunicipal Collaboration Projects. The one for the Village was for a Regional Economic Development Strategy project. The Town received one for a Regional Asset Management Strategy project. Also, the Town, Village and County have applied for a grant to establish a Regional Economic Development Officer.

The Town also received a larger grant for capital projects this year from the province. With the recommendations of our public works department, we will put these extra funds to good use.
