



**INFORMATION REQUIRED FOR A MODULAR / MOBILE / MANUFACTURED HOME PERMIT**  
(to be completed and attached to the building permit application)

A Development Permit is required to allow a modular / mobile / manufactured home to be located on a parcel of land. The development permit is obtained from the municipality.

- 1.  C.S.A. Z240 Building  
Required for a mobile or manufactured home having a deformation resistant steel frame and may sit on a gravel pad with blocking or on piles.

Or

- 2.  C.S.A. A277 Building  
Required for a modular home. A modular is a factory built home that is constructed on engineered wood or built up wood beams. Modular homes require a permanent foundation. They are not permitted on a gravel pad and blocking without engineering.

(typically found on a CSA certification label on the electrical panel, required to prove the unit has passed the Canadian Standards Association requirements. Label may come from other certification bodies other than CSA e.g. QAI, Intertek, etc.)

(found on a silver sticker with blue printing on the electrical panel)

- 8. Foundation type  full basement constructed of concrete or preserved wood  
 4' deep concrete strip footing and frost wall crawlspace  
 4' deep concrete pad and pier system crawlspace

 engineered designed pilings for concrete or steel pilings  
 wood blocking or pier foundation

Detailed drawings to be submitted. Foundations requiring engineering are to be accompanied by stamped drawings and arrangements are to be made with the designer for a required verification letter upon completion.
