



**BYLAW NO. 2010-892  
OF THE  
TOWN OF TWO HILLS**

**A BYLAW OF THE TOWN OF TWO HILLS, IN THE PROVINCE OF ALBERTA,  
TO REPEAL CERTAIN BYLAWS**

---

**Whereas**, pursuant to *Municipal Government Act*, a Council may pass bylaws for the purpose of repealing bylaws that are inoperative, obsolete, expired, spent or otherwise ineffective;

**And Whereas** the Town of Two Hills finds it necessary to repeal inoperative, obsolete, expired, spent and ineffective bylaws to promote an efficient Administration department;

**Now Therefore** by the virtue of the power conferred upon it by the Municipal Government Act, the Council for the Town of Two Hills enacts as follows:

**1. TITLE**

This bylaw shall be cited as “Repeal Certain Bylaws”
